Farmers markets - Increased the buying power of low-income NYC residents to purchase fresh produce by over \$98,000 through consumer payment options using Supplemental Nutrition Assistance Program (SNAP/EBT) dollars, Farmers Market Nutrition Program (FMNP) coupons, Women, Infant & Children (WIC) coupons, and NYC Department of Health and Mental Hygiene (NYCDOHMH) Health Bucks. Provided almost \$44,000 in coupons to seniors across NYC with a 99% redemption rate for our Healthy Seniors Healthy Shoppers (H2S2) program.

Healthy Living/Eating - Conducted 285 cooking demonstrations throughout NYC and distributed over 25,000 samples of plant-based recipes along with valuable nutrition information. Distributed over 25,000 pounds of free produce to participants of the cooking demonstrations by purchasing over \$43,000 worth of fresh fruits and vegetables directly from our farmers. Reached over 5,000 people with quick, low-cost, seasonally based recipes and nutrition information through the Food Talk newsletter.
